# 1) Scope of Copyright Protection in Thailand

- Copyright Act B.E. 2537 (AD 1994) and subsequent revisions
- The Berne Convention for the Protection of Literary and Artistic Work
- WTO TRIPs Agreement
- Computer Crime Act B.E. 2560 (2017)

Foreseen:

- 5th revision to Copyright Act
- MOU between IP owners and online platform sellers
- WIPO Copyright Treaty (WCT)
- WIPO Performances and Phonogram Treaty (WPPT)



# 1) Scope of Copyright Protection in Thailand

- Literary works
- Musical works
- Dramatic works
- Artistic works
- Cinematographic & Audiovisual works
- Sound recordings
- Software
- Databases ? Protected under Section 12 (compilation of data) or 4 (literary work)? Sui generis protection may be need in the future.



# 1) Scope of Copyright Protection in Thailand What is excluded from copyright protection in Thailand

- Excludes from protection: ideas, procedures, processes, systems, methods, concept, principles, discoveries, scientific or mathematical theories
- Requirements for a work to be protected under copyright in Thailand:
  - For an owner of original works only (**originality** of the work)
  - Physical expressions of ideas (fixation requirement)



# 1) Scope of Copyright Protection in Thailand

Often overlooked but there are significant advantages of recording copyright in Thailand:


- Not compulsory (copyright can be granted without recordation)
- Free of charge (no official fees) and quick (formality check used to be performed on same day as submitting application at DIP- new e filing system in place raises some questions though)
- Establishes ownership
- Establishes place and date of creation and publication and reverses in part the burden of proof on "infringer" = save litigation costs.
- Constitute a recorded right for future licenses or assignment
- International protection (Berne Convention)

Required supporting documents - A significant burden for applicants:

- 1) Copy of the created work + description of work
- 2) Power of Attorney:

Thai applicant:to be signed only in Thai version.Foreign applicant:to be signed and notarized and provided in Thai(and English) language

3) Certificate of Ownership:
 Thai applicant: to be signed only in Thai version.
 Foreign applicant: to be signed and <u>notarized</u> and provided in Thai (and English) language



4) Deed of assignment (if any) can be signed and <u>notarized</u> in English version only

- 5) Company Affidavit (needs <u>notarization by notary public that it is a true</u> <u>copy of an original</u>) in case that it is the applicant is company
- 6) Signed copy of passport or ID card of signatories of above documents

7) Employment agreement (some clarity required on whether this is needed as some applications seem to be accepted without by listing the company as author)

- 63% of Thai citizen chooses to buy counterfeited/pirated products due to the cheaper price\*
- 53.7% of Thai people become aware of IP rights in these 2 years\*
- 89.7% of Thai creator gave up on creating new works due to the copyright problem\*

#### 4) EABC Comments and Recommendations

- The EABC fully supports current initiatives and amendment to Thai Copyright Act to strengthen the legal framework for online infringement (as proposed for example under the proposed amendments to new Copyright Act of Thailand to be completed by specific regulations- not adopted yet);
- The EABC fully supports the initiative of asking ISPs (in particular market places) to enter into MoUs that would allow for higher co-operation with IP enforcement authorities and IPR owners;
- The EABC welcomes a closer co-operation of IPR owners and private sector in general with newly established online IP infringement enforcements bodies such as the online infringement suppression division of the Thai Department of Intellectual Property;



### 4) EABC Comments and Recommendations

- The EABC welcomes DIP efforts to implement a true online copyright recordation system (eventually using blockchain technology);
- The EABC <u>strongly</u> recommends however:
  (i) easing requirements for copyright recordation in Thailand and
  (ii) would like to suggest a revision of wording in Copyright certificate;
- The EABC recommends to continue to build awareness education activities though business groups of how using unauthorized versions is economically unattractive;
- The EABC would welcome some information/study to be performed about protection of databases in Thailand/SEA so as, to provide some information to IPR owners about protection of databases under Thai law.
